**Eligible expenses covered by the program;**

The total benefit can be put towards any of the following items, as determined by the member. You may be eligible for up to \$7,500.00 (GST exclusive) per TLaWC member per year (maximum of 3 years), the exception being the housing deposit benefit in which a lump sum may be paid. (subject to terms and conditions) You may select one of the following options;

<b>Rental Assistance</b>	\$7,500 (GST Exclusive) per TLaWC member per year (maximum of 3 years) - Rent - Bond
<b>General assistance</b>	\$7,500 (GST Exclusive) per TLaWC member per year (maximum of 3 years) - Relocation costs (removalist, transport) - Whitegoods, furniture & essentials (leased property only) - Connection of utilities - Mortgage repayments
<b>Purchasing Property – House Deposit</b>	Lump sum payment of \$22,500 (GST exclusive) for house deposit
<b>Renting with intent to purchase a property</b>	\$7,500 (GST Exclusive) per TLaWC member per year (maximum of 1 year) + Lump sum payment of \$22,500 (GST exclusive) for house deposit

**Evidence to be provided;**

1. The individual will need to show they are on the Taungurung Land & Waters Council membership list lodged with ORIC.
2. The member will need to provide a copy of the lease agreement or property title.
3. The member will need to show that the property being leased or acquired is on Taungurung country.
4. Mortgage bank statement (if available)
5. Invoices for relocation costs or connections to utilities
6. Housing deposit benefit requires evidence of housing on the property. Land purchases without housing infrastructure on the property will not be eligible for the benefit.
7. Statement confirming the intention to live on country permanently for the foreseeable future and to participate in Taungurung community activities where possible.

**Exclusions;**

1. TLaWC members who intend to use the property as a holiday house or investment property.
2. TLaWC members who do not have any of the eligible expenses listed in the eligible expenses section, If you already own your home outright
3. TLaWC members under the age of 18
4. One benefit amount payable per nuclear family moving onto Country

**Terms and conditions;**

1. Applicants will be notified of the outcome of their application within twenty (20) working days of TLaWC receiving all required documentation.
2. No cash or other reimbursements will be made to members.
3. Payments cannot be made to individuals – they can only be made to third party organisations.
4. If an applicant is dissatisfied with the outcome of their application, they can appeal against the decision in writing to the TLaWC Board.
5. Changes to or withdrawal of this program are at the TLaWC Board's discretion, subject to availability of funds.
6. There will be no accumulation or rollover of funds for year to year.
